ATT DWAR IL-HARSIEN TAL-INFORMAZZJONI PERSONALI / DATA PROTECTION POLICY

L-Att dwar il-Harsien tal-Infommazzjoni (Kap. 440 mil-Liġijiet ta' Malta), tirregola l-ipproċessar tal-infommazzjoni personali li ssir f'forma elettronika u manwali. Din l-iskola hi impenjata li tosserva dan l-Att dwar il-Harsien tal-Infommazzjoni.

L-Iskola Nazzjonali tal-Isport - Malta, teħtieġ li tipproċessa l-infommazzjoni personali sabiex tosserva l-obbligi legali skont l-Att dwar l-Edukazzjoni (Kap. 327), kif ukoll dispożizzjonijiet oħra statutorji. Id-dettalji tal-istudenti u tal-ġenituri/kustodji legali jintalbu meta l-istudenti jkunu se japplikaw biex jibdeu jattendu f'din l-iskola. Dawn id-dettalji huma meħtieġa għall-proċess tal-għażla u għall-operat ta' kuljum fit-tmexxija effiċjenti tal-iskola. Ir-rekords tal-istudenti jistgħu jinkludu wkoll ritratti. Għal dan l-iskop, il-ġenituri/kustodji legali huma mitluba biex jimlew formola ta' kunsens.

The Data Protection Act (Cap 440 of the Laws of Malta) regulates the processing of personal data held electronically and in manual form. The school is set to fully comply with the Data Protection Principles as set out in the Act.

The National Sport School - Malta, requires to process personal data to comply with legal obligations under the Education Act (Cap 327) and all other statutory provisions. Student and parent/legal guardian details are collected upon application for admission of a student to attend this school. Such details are required for selection criteria purposes and for the daily operations and efficient running of the school. Student records may also include photographs for which a separate consent will be sought from parents/legal guardians. The student details will incorporate the details of their parents/legal guardians to be contacted as necessary and to maintain a sound relationship with them, by involving them in the educational and sporting development of their child attending this school. It is the responsibility of the parents/legal guardians to provide the school with any amendments or changes to the registration details of the students to keep such information up to date. Such details may be disclosed to the Education authorities in accordance to the Education Act, as well as to hospitals/clinics/other medical professionals where a student needs medical treatment due to illness or injury suffered by him/her.

All data subjects are entitled to know what information the School holds and processes about them. A request to access their data may be submitted in writing to the Head of the National Sports School duly signed by the parents/legal guardians.
